Unfilled Reserved Seats under Regular seat fees shall be transferred in the following order of preference:

- (i) SC seats to ST
- (ii) ST seats to SC
- (iii) If no candidates are available in SC/ST categories, only then those vacant seats shall be considered for admission to other categories where there is no single representation.

(b) Non-Karnataka candidates under payment seats shall be allotted specialization branches as per option cum merit.

3. Karnataka State Law University (KSLU) was established in the year 2009, and all the Law Colleges of the State was affiliated to KSLU. University Law College, BUB being a constituent College of Bangalore University and LL.M. being a Professional course, (1) Karnataka candidate category and (2) non-Karnataka candidate category seats shall be treated and allotted as stated below:

(a) Karnataka candidates category:

Applicant/Candidates who has studied in one or more Government or Government recognized educational institutions for a minimum period of seven academic years commencing from 1st to 12th standard either continuously or in broken period and passed the qualifying examination in Karnataka.

(b) Non-Karnataka Candidate category: All Candidates who do not fulfil the requirements as above (a) are

Supernumerary seats shall be allotted only to Karnataka Candidates category except Jammu & Kashmir, Kashmiri Migrant and Children of Defence Personnel. Further these seats shall not exceed 3 numbers in each branch (excluding Foreign Nationals). If no applications are received under the supernumerary quota, the vacant seats shall not be transferred to other quota and shall freeze.

5. Filling of Vacant Seats in various categories/Quota:

(i) *Unfilled Hyderabad-Karnataka (H.K) Region/PWD seats:

If any seat fall vacant due to non-availability of applications in a under HK seat matrix, such seats shall be filled up by allotting the seat to the other applicants where there is no representation in a particular category:

(1) Constitution & Legal Order :

HK vacancy shall be transferred to 2B category and if there are no applicants in 2B, then to 3B and if there are no applicants in 3B, it shall be given to GM.

(2) Corporate & Commercial Law:

HK vacancy shall be transferred in the order of preference i.e., Cat I/3A/3B/GM.

(3) Criminal Law:

HK vacancy shall be transferred in the order of preference i.e., 2B/3A/3B/GM.

(4) Human Rights & Environmental Law:

PWD vacancy shall be transferred in the order of preference i.e., ST/Cat-I/3A/GM.

(5) Labour & Employment Law

(i) HK vacancy shall be transferred in the order of preference i.e., ST/Cat-I/2B/GM. PWD vacancy shall be transferred in the order of preference i.e., ST/Cat-I/2B/GM. If HK vacancy is already given to ST, then it shall be transferred in the sequence i.e., Cat-I/2B/GM. If the HK vacancy is given to Cat-I due to non-availability of HK applicants in ST, then PWD seat shall be operated from ST..... and further it shall be transferred to such categories where there is no representation (Cat I shall be skipped).

(ii) The same norms are applicable for unfilled vacancies under **payment fees also** provided if two or three categories are allotted only one seat, it shall be given to the meritorious applicant among clubbed categories in the sequential order i.e., (SC), (ST), (Cat-I/2A), (2B/3A/3B), (GM).

(6) REFUND AND FORFEITURE OF FEES

(1) Candidate for any reason may cancel his/her seat by submitting the following documents;

i) Original Provisional Admission Card

ii) Original Fee Receipt


iii) Application for cancellation of seat and refund of fee paid with clear & complete correspondence address with Bank details

and

(2) Refund shall be considered as per clause 4.1.3 of the UGC Fee Refund Policy 2023-24 vide D.O. No.F.2-71/2022(CPP-II) dated: 3rd July 2023, the following tier system for the refund of fees* remitted by the student shall be followed.

| Sl. No. | Percentage of Refund of fees* | Point of time when notice of withdrawal of admission is received in the University |
